Transfer Admission Guarantee (TAG) Agreement

The CSU Channel Islands (CI) Transfer Admission Guarantee (TAG) Agreement provides an opportunity for guaranteed admission to the undergraduate programs offered by Extended University (EU), provided that you satisfactorily complete all requirements listed and any additional criteria required for admission into the major that are in effect at the time you sign this agreement.

The Transfer Admission Guarantee is only available to Santa Barbara City College students seeking entrance into CSU Channel Islands-Extended University undergraduate programs .

Program Requirements

All requirements must be met prior to the start of the program of the term you are seeking entrance.

- ✓ **Complete a minimum of 60 transferable semester units/ 90 transferable quarter units.**
- ✓ **Complete a fully certified General Education package CSU GE or IGETC.**
- ✓ **Declare a major at the time of application to CSU Channel Islands.**
- ✓ **Complete ALL required preparation for the major courses listed in the CI Catalog in effect at the time you sign this agreement that appear on the local institution's major preparation articulation agreements available on ASSIST.org. Required courses for which there are no comparable articulated courses at CI will not affect admission to the university; however, students must still transfer with a minimum of 60 semester transferable units/ 90 quarter transferable units.**
- ✓ **Earn a minimum GPA of 2.00, in all transferable lower division coursework with grades of "C" or higher in Oral Communication, Written Communication, Critical Thinking, and Math/ Quantitative Reasoning.**
- ✓ **Complete at least 30 transferable credits from Santa Barbara City College.**
- ✓ **This TAG agreement only applies to the following Extended University Undergraduate programs:**

Deadlines and Procedures

- ✓ TAG agreements are available for fall and spring admission.
- ✓ You must sign and submit the TAG agreement at the same time you are submitting your application.
- ✓ Your agreement is not valid unless signed by a CI Extended University representative. You and your community college transfer center director will receive a copy of the signed agreement.
- ✓ All requirements for TAG must be met by the beginning of the start of the term in you are applying.
- ✓ If you miss any university-imposed deadline, your agreement is automatically void.

Student Responsibilities

- ✓ You are responsible for meeting all TAG requirements and notifying your community college of any changes that may affect your TAG eligibility.
 - ✓ You must submit a written notification of any changes in mailing address, email address, and/or telephone number(s) to the CI Extended University (brianne.keighley@csuci.edu) and your community college counselor.
 - ✓ You must submit an application for admission to CI via www.CSUMentor.edu.
 - ✓ You are responsible for meeting all CI deadlines communicated to you through Extended University.
