SBCC Measure P - Citizens' Bond Oversight Committee

Measure P Bond Extension passed by the SBCC District (Carpinteria to Goleta) on November 5, 2024. As required by law, the SBCC Board of Trustees must appoint the members of the Citizens' Bond Oversight Committee (CBOC) within 60 days of affirming the November 5, 2024 election results. The SBCC Board of Trustees affirmed the November 5, 2024 election results on December 19, 2024, opened applications that same day and closed applications at 5 pm on January 8, 2025. Applications will be reviewed from January 9, 2025 until selected by the SBCC Board of Trustees in their public meeting on Thursday, January 16, 2025.

SBCC <u>Board Policy 6740</u> and <u>Administrative Procedure 6740</u> establish the development of a CBOC and stipulate the purpose, their activities and member make-up. They are also listed below:

The purpose of the Citizens' Bond Oversight Committee is:

- To inform the public about the expenditure of Proposition 39 bond revenues;
- To review and report on the proper expenditure of Proposition 39 funds for facility construction; and
- To advise the public as to the District's compliance with the Proposition 39 requirements as contained in the California Constitution.

The Citizens' Bond Oversight Committee may engage in any of the following activities:

- Receive and review copies of the annual, independent performance audit;
- Receive and review copies of the annual, independent financial audit;
- Inspect facilities and grounds to ensure that bond revenues are expended properly;
- Receive and review copies of any deferred maintenance proposals or plans developed by the District; and
- Review efforts by the District to maximize bond revenues by implementing cost-saving measures.

The committee shall consist of at least seven members to serve for a term of two years and for no more than three consecutive terms. Members shall serve without compensation. The committee shall be comprised of at least:

- One member active in a business organization representing the business community located within the District;
- One member active in a senior citizen's organization;
- One member active in a bona fide taxpayer's organization;



- One member who is a student both currently enrolled in the District and appointed by the Associated Student Government. The student may serve up to six months after their graduation or certificate of completion;
- One member active in the support and organization of the District, such as a member of an advisory council or foundation; and
- Two members of the community at large.

Answer: I was a major supporter of the Measure P Campaign.

Question 1: Do you have any special area of expertise or experience that you think would be helpful to the committee?

Answer: Yes! For 20 years I was an adjunct instructor in the English Department. During that time, I introduced and served as the Coordinator for the Great Books Curriculum (GBC), a Chicago program lauded nationally. The first years, I had no budget and yet, by being creative, we



offered programs for our students, as well as connected the college with the

Santa Barbara Library and worked as a team with the Luria Library. We continued to grow -- even with just the \$25.00 photocopying budget my dean gave me every semester.

Eventually the GBC was the recipient of a private grant from the Apgar Foundation. I wrote up the grant myself. With the donor's generous support, the GBC flourished! We offered a fall semester "Great Read" partnered with Santa Barbara High School and distributed 1,000 books to every participating class and student. We hired UCSB classicists to work with participating instructors (who were also paid), conducted an essay contest for students and provided them with tutorials to review their drafts, hosted guest lecturers, and honored the winning student essayists at a celebratory luncheon in the SBCC Gourmet Dining Room. And, every year, I was able to account for every penny of the Apgar grant that was spent.

I know that's a lot to write, but I hope that in describing my work on the GBC, trustees will have a sense of my ability to design a successful program and then manage it through the years. The program was designed to serve all City College students, especially those who may not have had previous introduction to the great works of Western and World cultures. My background makes me well-suited to oversee how the bond monies will be spent in the proposals that are drafted.

Throughout my twenty years, I was an integral part of my department's community. I contributed much in time, expertise, willingness to be flexible and always available to teach at a moment's notice. That, too, qualifies me to serve on the oversight committee-- a group of individuals who will represent diversity in background, culture, and talents.

Question - 2: If you have served on other school district, college, or city or community committees please list and briefly describe your role.

Answer: In 1992, I volunteered for a one-year's service to the Santa Barbara Civil Grand Jury. I was an active member: initiating investigations, writing reports, and meticulous in researching. Throughout the 1980's into



the 1990's I was active in my son's schools, including serving on the board of the Monte Vista PTA, charter member of the PTSA at Lompoc High School, Board member for the Santa Barbara PTA Council (Recording Secretary), and I served two years as the Council President for Lompoc Unified PTA. Also during that period, I was appointed to the City of Lompoc for the Mobile Home Rent Stabilization Board, representing tenants.

Question - 3: Please note any additional information you feel should be considered as part of your application.

Answer: Yes! While living in Lompoc, I was the person behind the establishment of "Holly House," a residential home for young mothers and their infants, women who were recovering from drug addiction. I reached out to county agencies, including the Board of Supervisors and private non-profits. Working together, we created one of the first such homes for young families who would otherwise have been on the streets, or infants separated from their mothers. For my initiative in establishing a program for vulnerable families, I received the Maxwell House Real Hero Award and was honored in Washington, DC.

In my final year of teaching at Santa Barbara City College (2014-15), the faculty honored me by placing my name in nomination for the California Hayward Award, for Excellence in Teaching. I was among the first adjunct instructors to be so honored at SBCC.

As the Board of Trustees is undoubtedly aware, I opposed the passage of Measure P. I was vocal and wrote letters to the press voicing my opposition. However, I would like you to reflect on how that stance enhances my application. I will bring an objective view to the committee. The bond passed and received an overwhelming "Yea" vote from the community. I will honor that election vote. I, too, want to see that our precious tax dollars will serve the students and build upon an already fine educational program. It's important to have a "devil's advocate" serving on any committee, to ask the hard questions.

Here's what I mean: I taught debate in English 110. Every semester I required students to tell me if they felt strongly one way or the other on the debate position they were assigned. If so, I would place them on the opposite side. In every instance that I recall, those students thanked me



afterwards. Their teams were stronger for having the one person who could speak to the strength of the opponents' argument and at the same time, point out her own team's weaknesses. (And also, the students would share that while the debate had not changed their initial position, they were glad for the opportunity to consider the other side through objective, fact-based reasoning.) That's a valuable part of any team working together. I guess that's my point. Throughout my life, I've always worked well as part of a team, aiding to get to that desired endpoint and to arrive at consensus.

Answer: I bring a combination of leadership experience and a deep understanding of student needs from my active role in student government at Santa Barbara City College (SBCC). My involvement in the hiring committee for the Director of Health and Student Wellness at SBCC allowed me to serve as the student voice, ensuring that the candidates were attuned to the health and wellness needs of the student body.

These experiences have equipped me with strong skills in oversight, strategic planning, and effective communication, all of which make me well-suited to serve on the Citizens' Bond Oversight Committee.

Answer: I served on the hiring committee at Santa Barbara City College for the Director of Health and Student Wellness, where I participated in the selection process by providing insights from the student perspective. My contributions were focused on ensuring that the chosen candidate would enhance student support services and address key health and wellness issues on campus. Though we did not move forward with our selected candidates, the experience was extremely valuable to me.

Additionally, as a student representative on the Fund Advisory Committee at the Marine Military Academy, I was involved in advising on the allocation of funds to improve student services and initiatives, which further developed my understanding of financial oversight and the importance of responsible resource management.

Answer: My dedication to the success of SBCC is evident through my active participation in roles that support institutional growth and student welfare. I am passionate about ensuring that resources are used effectively to enhance educational opportunities for all students. My experiences, both at SBCC and the Marine Military Academy, have prepared me to contribute meaningfully to the goals of Measure P. Though we are not allowed to directly support measures on campus, I enjoyed canvassing and showing student support for Measure P at various rallies with Student Trustee Bruce Tan.
